NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED THAT:

Section 1. The rectification of the plantilla position in the Pagamutang Bayan ng Carmona from Medical Officer VI (SG 24) to Medical Officer V (SG 25) under item no. 193 of the Revised Plantilla of Personnel for CY 2018 of the Municipal Government of Carmona, is hereby approved.

Section 2. The payment of salary differential of Dr. Perez starting January 2010 to be determined by the Human Resources and Management Officer and Municipal Budget Officer is hereby further approved.

Section 3. The necessary fund for the purpose shall be taken from the Unexpended Appropriations for Vacant Positions Unfilled from January to April 2018.

Section 4. All municipal ordinances, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

Section 5. Let copy of this Ordinance be furnished the Office of the Sangguniang Panlalawigan, Office of the Mayor, Human Resource Management Office, Municipal Budget Office, PBC and other concerned offices for their information and appropriate action.


Section 6. This Ordinance shall take effect upon compliance of the mandatory posting requirement prescribed under RA 7160, otherwise known as the Local Government Code of 1991.
