MUNICIPAL ORDINANCE NO. 07-2016

AN ORDINANCE APPROVING THE CREATION OF MANDATORY PLANTILLA POSITIONS IN THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO) OF THE MUNICIPALITY OF CARMONA, CAVITE FOR INCLUSION IN THE REVISED PLANTILLA OF PERSONNEL

EXPLANATORY NOTES


WHEREAS, the Honorable Mayor, Dr. Dahlia A. Loyola has requested this Office for appropriate action with regard to the creation of the mandatory plantilla positions under the Municipal Disaster Risk Reduction and Management Office (MDRRMO) of the Municipality of Carmona, Cavite, to wit:

- 1) Local DRRM Officer III - SG-18
- 2) Local DRRM Assistant (3 slots) - SG-08

WHEREAS, with the end in view of upholding excellent public service through decent and empowered personnel, this Body deems it vital to create the aforesaid statutory positions in the MDRRMO of this municipality pursuant to *Republic Act No. 10121*, otherwise known as the *Philippine Disaster Risk Reduction and Management (PDRRM) Act of 2010* and Municipal Ordinance No. 014-2013 or the "Creation of the MDRRMO of Carmona, Cavite", and in compliance with *Joint Memorandum Circular No. 2014-1* dated 04 April 2014 issued by the National Disaster Risk Reduction and Management Council (NDRRMC), Department of the Interior and Local Government (DILG), Department of Budget and Management (DBM), and the Civil Service Commission (CSC);


WHEREAS, after a series of deliberations on the matter and consultation with the Human Resource Management Officer and the Municipal Budget Officer, this Body finds the same in order and appropriate meriting its approval;



NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED THAT:

Section 1. There is hereby created under the Municipal Disaster Risk Reduction and Management Office (MDRRMO) of the Municipality of Carmona, Cavite the following mandatory positions for inclusion in the Revised Plantilla of Personnel, in accordance with Qualification Standards set by the Civil Service Commission (CSC) and Index of Occupational Services, Position Titles, and Salary Grades for Local Government Units (IOS):

Section 2. The revised organizational structure and staffing pattern of the aforementioned office as embodied in the organizational chart and personnel schedule which is attached herewith and made an integral part hereof, is hereby approved.

Section 3. Let copy of this Ordinance be furnished the Civil Service Commission, Department of Budget and Management, Department of the Interior and Local Government (DILG), Office of the Sangguniang Panlalawigan and other concerned offices for their information and appropriate action.

Section 4. This Ordinance shall take effect immediately upon its approval.




