MUNICIPAL ORDINANCE NO. 08-2016

AN ORDINANCE DECLARING THE MONTH OF JULY OF EVERY YEAR AS THE "BLOOD DONORS MONTH" IN THE MUNICIPALITY OF CARMONA, CAVITE

Introduced by: Hon. Cesar M. Loyola and Hon. Bernie A. Ortiz

EXPLANATORY NOTES

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the delivery of health services and facilities is one of the basic functions and responsibilities of all local government units at all levels;

WHEREAS, Republic Act No. 7719, also known as the "National Blood Services Act of 1994," promotes and encourages voluntary blood donation, in order to provide an adequate, safe, affordable and equitable distribution of supply of blood and curb the hazards caused by the commercial sale of blood;

WHEREAS, assurance of adequate supply of volunteer-sourced human blood depends on a sustained promotion of the advantages of voluntary blood donation;

WHEREAS, on 09 June 1997, former President Fidel V. Ramos officially declared the month of July as Blood Donors Month by virtue of Proclamation No. 1021 to recognize the men and women of the country who freely and voluntarily give part of themselves to humanitarian act that has served thousands of human lives;

WHEREAS, the Local Government of Carmona has been consistently receiving annually since 2001 the Regional and Provincial Sandugo Awards for its genuine support and commitment to the National Voluntary Blood Services Program of the Department of Health;

WHEREAS, after a thorough study and series of deliberations on the matter, this Body finds the same in order meriting its enactment;


NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED THAT:

Section 1. There is hereby declared the month of July of every year as "**Blood Donors Month**" in the Municipality of Carmona, Cavite.

Section 2. It is the policy of this Municipality to:

- a. Promote and encourage voluntary blood donation and to instill public consciousness on the principle that blood donation is a humanitarian act;
- b. Provide for adequate, safe and affordable supply of blood by promoting and encouraging voluntary blood donation; and
- c. Inform the public of the importance of voluntary blood donation to curb hazards caused by commercial sale of blood.

Section 3. All establishments, offices, institutions, non-governmental organizations, peoples' organizations, and individuals are hereby enjoined to observe this important event and to align their efforts in support of the Municipality's Blood Donation Program under the auspices of the Municipal Health Office (MHO) in coordination with the concerned national government agencies and other partner stakeholders.

Section 4. The MHO is hereby tasked to spearhead the observance of the "Blood Donation Month" and to institutionalize relevant programs and activities including, but not limited to the following:

- a. *Voluntary blood donation activity of LGU and private companies/institutions;*
- b. *Blood Donors Recognition;*
- c. *Advocacy on blood donation;*
- d. *Dissemination of IEC materials, etc.; and*
- e. *Other relevant programs and activities;*

Section 5. To carry out the purposes of this Ordinance, the Municipal Mayor is hereby authorized to sign, for and in behalf of the Municipality, any and all the necessary partnership agreements with other LGUs, national government agencies and stakeholders.

SECTION 6. The required amount to carry out the mandate under this Ordinance shall be charged against the 2016 Local Expenditure Program and the succeeding budgetary appropriations of this Municipality.

SECTION 7. All municipal resolutions/ordinances, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

SECTION 8. This Ordinance shall take effect upon compliance with the mandatory posting requirement prescribed under RA 7160, otherwise known as the Local Government Code of 1991.






