MUNICIPAL ORDINANCE NO. 09-2016

AN ORDINANCE DECLARING THE THIRD WEEK OF OCTOBER OF EVERY YEAR AS THE "ATTENTION DEFICIT/HYPERACTIVITY DISORDER (AD/HD) AWARENESS WEEK" IN THE MUNICIPALITY OF CARMONA, CAVITE

Introduced by: Hon. Cesar M. Loyola and Hon. Alberto H. Ocampo

EXPLANATORY NOTES

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that "the State shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, accords every local government unit power and authority to promote the general welfare within its territorial jurisdiction, including among others, the promotion of health and safety of its constituents;

WHEREAS, Attention Deficit/Hyperactivity Disorder or AD/HD is a chronic brain disorder with social, academic and emotional impacts which can affect an estimated four (4) million Filipinos nationwide;

WHEREAS, lack of understanding and awareness about AD/HD leads to misconceptions and social stigma which hinder access to effective treatment, increases the risk of co-morbid conditions and complications such as conduct disorder, oppositional defiant disorder and anti-social disorder;

WHEREAS, the unmitigated condition of AD/HD may lead to the increased incidence of out-of-school youths and child abuse and neglect;

WHEREAS, early identification, intervention and support to AD/HD can make a big difference in the children's success to have a normal life;

WHEREAS, after a thorough study and series of deliberations on the matter, this Body finds the same in order meriting its enactment;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED THAT:

Section 1. Short Title. This Ordinance shall be known and cited as the "**Attention Deficit/Hyperactivity Disorder AD/HD Awareness Week**" in the Municipality of Carmona, Cavite.

Section 2. There is hereby declared the third week of October of every year as the Attention Deficit/Hyperactivity Disorder AD/HD Awareness Week in the Municipality of Carmona, Cavite under the auspices of the Municipal Health Office (MHO) and Persons with Disability Affairs Office (PDAO) in coordination with the concerned national government agencies and other partner stakeholders.

Section 3. It is the policy of this Municipality to promote a supportive environment among communities to enable persons with AD/HD to live with dignity and enable them to function independently and contribute productively to society.

Section 4. All municipal officials and employees, establishments, offices, institutions, non-governmental organizations, peoples' organizations, and individuals are hereby enjoined to actively participate and support the observance thereof.

Section 5. The MHO and PDAO are hereby tasked to spearhead the observance of the "Attention Deficit/Hyperactivity Disorder (AD/HD) Awareness Week" and to institutionalize relevant programs and activities for the purpose.

Section 6. The Municipal Mayor is hereby authorized to sign, for and in behalf of the Municipality, any and all the necessary partnership agreements with other LGUs, national government agencies and stakeholders to carry out the purposes of this Ordinance.

SECTION 7. The required amount to fulfill the mandate under this Ordinance shall be charged against the 2016 Local Expenditure Program and the succeeding budgetary appropriations of this Municipality.

SECTION 8. All municipal resolutions/ordinances, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

SECTION 9. This Ordinance shall take effect upon compliance with the mandatory posting requirement prescribed under RA 7160, otherwise known as the Local Government Code of 1991.




