MUNICIPAL ORDINANCE NO. 10-2016

AN ORDINANCE DECLARING THE LAST WEEK OF OCTOBER OF EVERY YEAR AS "FOOD SAFETY AWARENESS WEEK" IN THE MUNICIPALITY OF CARMONA, CAVITE

Introduced by: Hon. Cesar M. Loyola and Hon. Huberto A. Hugo

EXPLANATORY NOTES

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that "the State shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, accords every local government unit power and authority to promote the general welfare within its territorial jurisdiction, including among others, the promotion of health and safety of its constituents;

WHEREAS, one of the primary concerns of the Local Government of Carmona is food safety;

WHEREAS, this Municipality is desirous to create public awareness and to educate people on food safety in order to reduce and ultimately eradicate food poisoning and other foodborne illness which in some cases resulted to death;

WHEREAS, there is a need to conduct massive education campaign to educate the public especially food handlers and processors on how to ensure safety on food that are handled, manufactured, produced and/or served;

WHEREAS, after a thorough study and series of deliberations on the matter, this Body finds the same in order meriting its enactment;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED THAT:

Section 1. Short Title. This Ordinance shall be known and cited as "Food Safety Awareness Week" in the Municipality of Carmona, Cavite.

Section 2. There is hereby declared the last week of October of every year as the "Food Safety Awareness Week" in the Municipality of Carmona, Cavite under the auspices of the Municipal Health Office (MHO) in coordination with the concerned national government agencies and other partner stakeholders.

Section 3. It is the policy of this Municipality to protect and promote the right to health of the constituents and instill health consciousness among them.

Section 4. All establishments, offices, institutions, non-governmental organizations, peoples' organizations, and individuals are hereby enjoined to actively participate and support the observance thereof.

Section 5. The MHO is hereby tasked to spearhead the observance of the "Food Safety Awareness Week" and to institutionalize relevant programs and activities for the purpose.

Section 6. The Municipal Mayor is hereby authorized to sign, for and in behalf of the Municipality, any and all the necessary partnership agreements with other LGUs, national government agencies and stakeholders to carry out the purposes of this Ordinance.

SECTION 7. The required amount to fulfill the mandate under this Ordinance shall be charged against the 2016 Local Expenditure Program and the succeeding budgetary appropriations of this Municipality.

SECTION 8. All municipal resolutions/ordinances, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

SECTION 9. This Ordinance shall take effect upon compliance with the mandatory posting requirement prescribed under RA 7160, otherwise known as the Local Government Code of 1991.






