MUNICIPAL ORDINANCE NO. 11-2016

AN ORDINANCE SEPARATING FROM THE *SORTEO NG BUKID NG BAYAN* A PORTION, CONSISTING OF THREE THOUSAND (3,000) SQUARE METERS, MORE OR LESS, OF *SORTEO* LOT NO. 69, IDENTIFIED AS CADASTRAL LOT NO. 760, CAD-285-D, CARMONA CADASTRE, WITH TAX DECLARATION NO. 04-0010-00685, TO BE USED AS AN OFFICE AND MOTORPOOL SITE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS SUB-DISTRICT ENGINEERING OFFICE (DPWH CAVITE SUB-DEO) LOCATED AT BARANGAY LANTIC, CARMONA, CAVITE

EXPLANATORY NOTES

WHEREAS, there is a need to provide a suitable site for the DPWH Sub-DEO office and motorpool considering the utilization of its road maintenance equipments for a quick response to calamities and other related emergency situations and the expected escalation of infrastructure development projects in Carmona particularly along Sugar Road;

WHEREAS, the provision of a satellite office with motorpool will further capacitate the DPWH Cavite Sub-DEO in the implementation of various infrastructure projects and maintenance of roads, bridges, and other facilities within the jurisdiction of DPWH Region IV-A;

WHEREAS, the subject lot, being more particularly described in Annex "A" attached hereto and incorporated herein, is part of the "*Sorteo ng Bukid ng Bayan*" (lottery of *Sorteo* farmlots);

WHEREAS, after a series of committee meetings, sectoral consultations and public hearing conducted, the joint Committees on Good Governance, Public Ethics & Accountability and Agriculture have gathered public support on the issues at hand;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED THAT:

Section 1. The separation and allocation of a portion, consisting of Three Thousand (3,000) square meters, more or less, of Sorteo Lot No. 69, identified as Cadastral Lot No. 760, Cad-285-D, Carmona Cadastre, with Tax Declaration No. 04-0010-00685, for use of the DPWH Cavite Sub-DEO as an office and motorpool located at Barangay Lantic, Carmona, Cavite, are hereby approved.

Section 2. The Municipal Mayor is hereby authorized to enter into a Deed of Usufruct with the DPWH Cavite Engineering Office for the purpose herein stated.

Section 3. Let copy of this Ordinance be furnished the Sangguniang Panlalawigan, DPWH Cavite Engineering Office, Municipal Mayor's Office, Municipal Engineering Office, Municipal Agriculture Office and other concerned offices for their information and appropriate action.

Section 4. All municipal resolutions/ordinances, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

Section 5. If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 6. This Ordinance shall take effect upon compliance of the mandatory posting requirement prescribed under RA 7160.
