AN ORDINANCE RENAMING REGIONAL WATER LABORATORY TO CARMONA WATER LABORATORY

Introduced by: Hon. Cesar M. Loyola and Hon. Bernie A. Ortiz

EXPLANATORY NOTES

WHEREAS, there is a need to change the name of Regional Water Laboratory to Carmona Water Laboratory in order to meet the requirement of the Department of Health – Bureau of Health Facilities and Services for accreditation of Laboratory for Drinking Water Analysis;

WHEREAS, this legislative measure is in conformity with Articles 22 and 23 of the Implementing Rules and Regulations (IRR) of the Local Government Code of 1991;

WHEREAS, after due study and deliberation thereof, this Body thru the Committee on Health and Environmental Protection finds the same in order meriting its approval;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED THAT:

Section 1. Short Title. – This Ordinance shall be known and cited as the “Carmona Water Laboratory Ordinance” of the Municipality of Carmona, Cavite.

Section 2. The change of name of Regional Water Laboratory to Carmona Water Laboratory is hereby approved.

Section 4. All municipal resolutions/ordinances, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

Section 5. This Ordinance shall take effect upon compliance of the mandatory posting requirement prescribed under RA 7160.


