RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO USUFRUCT AGREEMENTS WITH THE CARMONA WATER DISTRICT REGARDING THE CONSTRUCTION OF THREE (3) ADDITIONAL WATER PUMPING STATIONS AT BRANGAYS (8) ROSARIO, CABILANG BAYBAY AND MABUHAY, CARMONA, CAVITE

WHEREAS, the Municipal Mayor has requested this Office to adopt an urgent resolution authorizing the Municipal Mayor to enter into Usufruct Agreements with the Carmona Water District (CWD) regarding the voluntary grant of the right of usufruct over the following lots which will be used for the construction of three (3) additional pumping stations, to wit:

WHEREAS, there is a need to construct additional pumping stations to address insufficient water supply in the aforementioned affected areas;

WHEREAS, this Body is cognizant of the urgency of the need to provide a better water supply to the constituents that has significant effects on their socio-economic development;

WHEREAS, this Municipal Government, while retaining the naked and full ownership over the abovementioned parcels of land where three (3) additional pumping stations will be constructed, is willing to give the CWD the right of usufruct over the same with the end in view of providing safe, adequate and economical water to its concessionaires;

WHEREAS, after due study and deliberation thereof, this Body finds the terms and conditions of the aforesaid instruments in order meriting its immediate approval;

NOW, THEREFORE, on motion of **HON. CESAR M. LOYOLA**, duly seconded by **HON. ALMARIO S. ZAMORA**, and approved by all the members present in session assembled, **BE IT RESOLVED AS IT HEREBY RESOLVES TO AUTHORIZE THE MUNICIPAL MAYOR TO ENTER INTO USUFRUCT AGREEMENTS WITH THE CARMONA WATER DISTRICT REGARDING THE CONSTRUCTION OF THREE (3) ADDITIONAL WATER PUMPING STATIONS AT BRANGAYS (8) ROSARIO, CABILANG BAYBAY AND MABUHAY, CARMONA, CAVITE.**
