MUNICIPAL ORDINANCE NO. 17-2018

AN ORDINANCE AMENDING SECTION 5 (b) OF MUNICIPAL ORDINANCE NO. 005-2015, OTHERWISE KNOWN AS THE "SCHOLARSHIP PROGRAM ORDINANCE" OF THE MUNICIPAL GOVERNMENT OF CARMONA, CAVITE

Introduced by: Hon. Hon. Bernie A. Ortiz and Hon. Amable M. Lontok

EXPLANATORY NOTE

WHEREAS, in 1997, the Municipal Government of Carmona has established a college scholarship program dubbed as the "Iskolarship para sa mga Anak ng Carmona" (ISAAC) with its approved Implementing Guidelines;

WHEREAS, in 1998, a Scholarship Committee was created to further enhance, improve and execute the program. After a year, it was renamed as "Iskolar ng Bayan ng Carmona, Cavite" or IBCC;

WHEREAS, with the passage of Republic Act 10931 or the "Universal Access to Quality Tertiary Education", which is a very strong pillar or cornerstone of his Excellency, President Rodrigo Roa Duterte's social development policy, local government units have become liberalized in terms of providing opportunities to financially challenged but deserving students to pursue higher education at no expense;

WHEREAS, the IBCC Committee has recommended the revision of the scholarship grant classifications and benefits of the Municipal Government's scholarship grantees;

WHEREAS, after due study and deliberation on the matter, this Body finds the same in order and beneficial to the constituents especially the youth sector, thus meriting its approval;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED THAT:

SECTION 1. Section 5 (b) of Municipal Ordinance No. 005-2015, otherwise known as the "Scholarship Program Ordinance" of the Municipal Government of Carmona, Cavite is hereby amended to read as follows:

"SECTION 5. THE SCHOLARSHIP GRANT CLASSIFICATIONS AND BENEFITS


Under this Ordinance, there are two (2) kinds of Scholarship Grants, with the following benefits:

a. **ECAP FINANCIAL GRANT** - The Expanded College Assistance Program or ECAP of the Municipal Government of Carmona aims to aid deserving students/out-of-school youth to avail of tertiary education from reputable colleges or universities anywhere in Region IV-A or the National Capital Region (NCR).

a1. Fixed grant in the amount of TEN THOUSAND PESOS (PhP10,000.00) per semester or PhP2,000.00 per month in five (5) semestral months, subject to the terms and conditions of the grant.

a2. Recipients of ECAP shall be as follows:

- i. Those who passed the qualifying exams and interview and whose family income is below poverty threshold;
- ii. Those who graduated with highest honors from any secondary institutions within the Municipality and whose family income is below poverty threshold; or
- iii. Those who exhibit great talent in culture and the arts and sports and whose family income is below poverty threshold.

b. **CSP SUBSIDIARY SCHOLARSHIP GRANT** – or “Comprehensive Scholarship Program” is a regular scholarship program of this Municipal Government conceptualized to help deserving students/out-of-school youth who opt to avail free tertiary education at the Cavite State University – Carmona Campus.

b1. Recipients of CSP who passed the qualifying examinations and interview and are found to be qualified under Section 8 of the Scholarship Program Ordinance (MO # 005-2015), shall receive the following benefits:

- i. Monthly stipend of PhP2,500.00;
- ii. Book allowance of PhP1,500.00 per semester;
- iii. Thesis (dissertation) grant of PhP7,000.00; and
- iv. Graduation fee of PhP2,500.00.”

SECTION 2. Repealing Clause. – All municipal ordinances, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

SECTION 3. Separability Clause. – If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. Effectivity Clause. – This Ordinance shall take effect upon compliance of the mandatory posting requirement prescribed under RA 7160, otherwise known as the Local Government Code of 1991.






