MUNICIPAL RESOLUTION NO. 49-2018

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO MEMORANDA OF UNDERSTANDING WITH MANILA WATER PHILIPPINE VENTURES, INC. AND MAYNILAD WATER SERVICES, INC. FOR THE CONDUCT OF THEIR RESPECTIVE PRE-FEASIBILITY STUDY FOR THE WATER SUPPLY CONCESSION/BULK WATER, WASTEWATER PROJECT, AND SEPTAGE MANAGEMENT PROGRAM OF THE MUNICIPAL GOVERNMENT OF CARMONA

WHEREAS, the Honorable Mayor, Dr. Dahlia A. Loyola has endorsed to this Office the Letters of Intent of Manila Water Philippine Ventures, Inc. (Manila Water) and Maynilad Water Services, Inc. (Maynilad) with regard to their interest to enter into a Memorandum of Understanding with the Municipal Government of Carmona to conduct due diligence to come up with their respective Pre-Feasibility Study on water supply concession/bulk water, Wastewater Project, and Septage Management Program of this Municipal Government;

WHEREAS, it is incumbent upon the Municipal Government of Carmona to abide by the legal mandates of the applicable laws (RA 7160; PD 856 or the Sanitation Code of the Philippines; RA 9275 or the Philippine Clean Water Act of 2004; Municipal Ordinance No. 017-2013 or the Carmona Sewerage and Septage Management Ordinance; and Supreme Court Decision on 18 December 2008 by virtue of a "Writ of Continuing Mandamus";

WHEREAS, Manila Water and Maynilad will undertake the conduct of their respective Pre-Feasibility Study on water supply concession/bulk water, Wastewater Project, and Septage Management Program of the Municipal Government within a period of at least three (3) months at their own expense to acquire the necessary technical, economic and financial studies and evaluation that may be necessary for them to arrive at their best development proposal for the said project/program;
