MUNICIPAL RESOLUTION NO. 51-2018

RESOLUTION IMPOSING A MORATORIUM ON THE ISSUANCE OF LOCATIONAL CLEARANCE, DEVELOPMENT PERMIT, BUILDING/OCCUPANCY PERMIT, AND/OR MAYOR'S PERMIT ON ALL NEW APPLICATIONS FOR LAUNDRY SHOPS AND WATER REFILLING STATIONS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPAL GOVERNMENT OF CARMONA, CAVITE

WHEREAS, Ms. Edwina R. Ledesma, Municipal Treasurer requested this office for the adoption of a resolution imposing a moratorium on all new applications for Locational Clearance, Development Permit, Building/Occupational Permit, and/or Mayor's Permit with regard to the establishment of laundry shops and water refilling stations within the territorial jurisdiction of the Municipal Government of Carmona;

WHEREAS, according to the Municipal Treasurer, there are already a total of 64 laundry shops and water refilling stations in Carmona which contribute to the recurring problem on insufficient water supply of a great number of concessionaires of the Carmona Water District;

WHEREAS, this Body believes that it would be more beneficial for both the constituents and owners of said businesses in terms of investment returns and enhanced delivery of basic services if proliferation of said businesses will be discouraged;

WHEREAS, there is a need to control and regulate the said businesses for the best interest of the majority of the constituents;

WHEREAS, based on the foregoing premises and after due study and deliberation thereof, finding the request in order and appropriate, this Body opts to impose a moratorium on new applications for the establishment of laundry shops and water refilling stations in the Municipality of Carmona;

NOW, THEREFORE, on motion of **HON. ROEL Z. MANARIN**, duly seconded by **HON. CESAR M. LOYOLA**, and unanimously approved by all the members present in session assembled, BE IT RESOLVED AS IT HEREBY RESOLVES TO IMPOSE A MORATORIUM ON THE ISSUANCE OF LOCATIONAL CLEARANCE, DEVELOPMENT PERMIT, BUILDING/OCCUPANCY PERMIT, AND/OR MAYOR'S PERMIT ON ALL NEW APPLICATIONS FOR LAUNDRY SHOPS AND/OR WATER REFILLING STATIONS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPAL GOVERNMENT OF CARMONA, CAVITE.

BE IT FURTHER RESOLVED, that the Municipal Mayor, Municipal Zoning Administrator, Building Official, and Municipal Treasurer are hereby authorized and enjoined not to accept any applications for Locational Clearance, Development Permit, Building/Occupancy Permit, and/or Mayor's Permit with regard to the new establishment of laundry shop and/or water refilling station within the Municipality, unless there are reasonable grounds under justifying circumstances for the grant thereof.

BE IT FINALLY RESOLVED, to furnish all others concerned with copies of this resolution for their information and appropriate action.
