MUNICIPAL ORDINANCE NO. 01-2018

AN ORDINANCE APPROVING THE ABOLITION OF CERTAIN PLANTILLA POSITIONS IN THE REVISED PLANTILLA OF PERSONNEL FOR CY 2018 OF THE MUNICIPAL GOVERNMENT OF CARMONA, CAVITE

Sponsored by Hon. Amable M. Lontok and Hon. Roel Z. Manarin

EXPLANATORY NOTE

WHEREAS, the Municipal Mayor has requested this Body to enact an ordinance abolishing certain positions contained in the Plantilla of Personnel for CY 2018;

WHEREAS, Section 76 of Republic Act 7160 or the Local Government Code of 1991 states that "every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";

WHEREAS, there is a need to abolish certain positions in the various offices of this municipality in lieu of the creation of new position items under Municipal Ordinance No. 07-2017 with the end in view of bringing beneficial reforms in this Municipality;

WHEREAS, settled is the rule that the power to abolish a position or an office is necessarily implied from the power to create the same;

WHEREAS, after a series of deliberations on the matter and due consultation with the Human Resource Management Officer and the Municipal Budget Officer, this Body finds the same in order and appropriate meriting its approval;

Section 3. All municipal ordinances, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

Section 4. This Ordinance shall take effect upon compliance with the mandatory posting requirement prescribed under RA 7160, otherwise known as the Local Government Code of 1991.




