## **NOTICE OF AWARD**

Dear Mr. Feliciano:

Acting favorably on the recommendation of the City of Carmona Bids and Awards Committee as embodied in its Resolution No. 0891 Series of 2025 dated July 28, 2025, **MEGAWIDE ONEMOBILITY CORPORATION** is hereby selected as the Proponent of the City Government of Carmona and is awarded the Joint-Venture Agreement (JVA) for the implementation of the South-Luzon Integrated Terminal Exchange (SLITX) Project, with an estimated total project cost of **Eight Hundred One Million Pesos (Php 801,000,000.00)**.

This award and the execution of the JVA are subject to Proponent compliance with and submission of the following:

- in case an SPC has already been formed for purposes of undertaking the Project, proof of registration in accordance with Philippine laws;
- sworn secretary's certificate with attached board resolution, or power of attorney designating the authorized signatory to the JVA;
- proof of commitment of the required equity contribution through an undertaking to infuse the required equity contribution into the Project by the SPC;

- letter from reputable financial institutions expressing their willingness to provide sufficient credit facilities as required in the Proponent's Financial Proposals; and
- Construction Performance Security in the amount and form required in the JVA.

The Bid Security of the Proponent will be returned after the posting of the prescribed performance security and the signing of the JVA.

Within twenty (20) calendar days from receipt of this Notice of Award or unless specified in the JVA, the Proponent must submit all the requirements and comply with all the conditions for the award as stated above.

Within five (5) calendar days from the submission of proof of compliance with all the requirements, the City Government of Carmona will advise the Proponent whether or not its submissions are satisfactory. Within five (5) days from the receipt of the advice of the City Government of Carmona that all conditions have been fulfilled, the Proponent must sign the execution copy of the JVA, unless another mutually convenient date has been set by the Parties.

Failure to comply with the foregoing requirements will result in the revocation of the award, the forfeiture of the Bid Security.
